1. Minutes of the last meeting were discussed and approved by the members. Advertisers can be sought for the other issues. Dr. Namrata Chhabra offered to bear the cost of third issue.

3. Treasurer Dr. A P Singh presented financial transactions of the year 2013, which were audited by the auditor Dr. Vandna Jowaheer. The auditor signed the annual return form of the year 2013.

The meeting ended at 2:30 pm with a vote of thanks from the chairperson and tea.
